

Contract

Please confirm the following before making payment.

This trip is planned, offered, and operated by Traveli, Inc. and customers participating in this trip are entering into a solicitation-type tour contract.

■ How to apply the tour and formation of contract

(1) The customer is requested to complete the Travel-Ai's application form and make a deposit.

The deposit is appropriated to cover a portion of the travel costs.

The Travel Contract shall become effective when Travel-Ai agrees to sign the contract and receives the deposit from the customer.

(2) In case of application via telephone, The Travel Contract shall become effective when we received the deposit.

After formation of the Travel Contract, the entire amount of the travel fee must be paid by the date designated by Travel-Ai.

Deposit(per person)/20% of the total fee or more

■ Trip fee to be paid

The trip fee to be paid is the trip fee shown in the brochure,

The total price to be paid will be the sum of the entrance fee, experience fee, insurance fee, and consumption tax.

The trip fee that cannot be paid is the total of the trip fee not shown in the brochure.

■ Change of Content of Travel Contract, Cancellation of Travel Contract

Even after the conclusion of the Travel Contract, if natural disaster, suspension of service of transportation, order of government authority, etc. or any other event that is beyond control of Travel-Ai occur, we may call off the tour or change the content of the travel schedule and Travel Service.

■ Cancellation Charges

Cancellation of the tour contract will be subject to the following cancellation fees.

11 days prior to departure: No charge,

10 to 8 days prior to the start of the tour: 20% of the tour fee.

7 to 2 days prior to the start of the tour: 30% of the tour fee.

The day before: 50% of the trip fee.

On the day of cancellation or without notice: 100% of the trip fee.

■ Special Indemnity

While the customer is participating in Agent-Organized Travel, if the customer suffers any bodily injury or their lives or damage to the hand baggage, Travel-Ai will pay the hospitalization condolence money, damage indemnity for the damage to the hand baggage under special indemnity provisions of the Travel-Ai stipulations.

■ Guarantee of Travel Schedule

In the case where any significant change is made to the contract content on the brochure and which is indicated in Travel-Ai's standard travel agent contract, Travel-Ai will pay compensation for change in the amount of the travel fee.

■ Management of Travel Schedule The contract and conditions for the customer who will participate in the travel is depend on Travel-Ai's travel contract. We have more details and travel contract in the company. Please have a look and apply.

■ Travel conditions data are current as of September 1, 2024.
